Shri Partha Chatterjee

Shri Partha Chatterjee is Hon'ble Cabinet Minister, Commerce & Industries, Parliamentary Affairs, Public Enterprise and Industrial Reconstruction, Information Technology, Govt. of West Bengal

He was born in Kolkata, and holds a post-graduate degree in business administration. He worked as a senior HR professional with Andrew Yule Ltd. before making foray into active politics.

He was elected a MLA from Behala Paschim constituency in 2001, and subsequently re-elected from the same constituency in 2006. In 2011 he won by a margin of 59,021 votes.

He was sworn in as a Cabinet Minister in Chief Minister Ms Mamata Banerjee's ministry on 20 May, 2011 and allotted the portfolios of commerce and industry, public enterprises, information technology and parliamentary affairs.

He was nominated deputy leader of the house in 2011. He was leader of the opposition in the West Bengal assembly during 2006-2011.



Parthasarathi Shome

Dr. Parthasarathi Shome is Director and Chief Executive, ICRIER. Prior to this he was Chief Economist, Her Majesty's Revenue & Customs (HMRC), UK. His responsibilities included accountability for quality assurance in HMRC's analytical work and he was Chair, Analysis and Research Committee (for prioritising HMRC research projects); Chair, Evaluation Forum (on HMRC evaluation of Government tax measures); Chair, HMRC VAT Gap Governance Group; and Member, Chancellor's Business-Government Forum on Tax and Globalisation. (previous Government).

Earlier Dr. Shome has been Adviser to Indian Finance Minister (October 2004 – January 2008); Member, Prime Minister's Trade & Economic Relations Committee; Chair, Empowered Committee for Tax Computerization; Permanent Invitee, Empowered Committee (EC) of State Finance Ministers for VAT; and Co-Convener, first report on Goods and Services Tax (GST) submitted to EC and Union FM in December 2007. He has also held senior positions at the IMF between 1983-2004 including Director, IMF Singapore Training Institute (2001-03), and Chief, Tax Policy Division (1992-95). He was Chairman, Tax Policy and Tax Administration task force, India's Tenth Five Year Plan (2000-01), and Ninth Five Year Plan (1996-97); RBI Professor, ICRIER (1999-2001); Director, National Institute of Public Finance & Policy (1995-97); Professor/ Associate Professor/ Assistant Professor, The American University, Washington DC (1975-83); Visiting Fellow, Delhi School of Economics (1981); Academic Visitor, London School of Economics (1981–1982); and Visiting Fellow, Australian National University (1982).

Dr. Shome has authored and edited five books including *Tax Policy and Administration in South and South East Asia* (Routledge, 2006); *India's Fiscal Matters* (OUP, 2002); and *Tax Policy Handbook* (IMF, 1995); and over 50 refereed articles in journals including *Journal of Economic Theory, Oxford Economic Papers, IMF Staff Papers, Journal of Public Economics, Public Finance, Labour and Society, and <i>International Social Security Review*.

Dr. Shome has a M.A. in Economics from University of Rochester, New York and Delhi School of Economics. He holds a Ph.D. in Economics from Southern Methodist University (SMU), Dallas, and received the Jeanne S. Mattersdorf Award of National Tax Association of America for his Ph.D. thesis as an "outstanding student of taxation and public finance".

He received the highest civilian honour of the Brazilian Government for a non-Brazilian the "Commander of the Order of the Southern Cross" for contributions to tax reform in Brazil, in 2000.



Shrivardhan Goenka

Mr. Shrivardhan Goenka, is Director of the Duncan Goenka Group, which has interests in a wide range of industries including Tea, Fertilizer, Cement, Paper, Engineering, Chemicals, Synthetic Fibres, etc. He is also Director of Andhra Cements Limited, Duncans Tea Limited, Star Paper Mills Limited, and Stone India Limited.

Mr. Goenka is also President, Indian Chamber of Commerce, Calcutta, Member of the National Executive Committee, Federation of Indian Chambers of Commerce and Industry (FICCI) and Member, Entrepreneurs' Organization (A global community of business owners across 38 countries).

He holds an MBA from the Kellogg School of Management, Northwestern University, USA.



Rajeev Singh

Dr. Rajeev Singh has been appointed as the Director General, Indian Chamber of Commerce, Kolkata with effect from 1st September, 2006. Prior to this, he was actively involved with CII for more than five years as Regional Director, posted in Chandigarh & Ahmadabad and subsequently in Kolkata. Dr. Singh has done extensive work in the fields of Central & State Policy Advocacy, Service Sector, Agro Business, Taxation and Bio-Technology. Dr. Singh's distinguished professional career spans over seventeen years. He started with the Rajasthan Oil Federation as Deputy Manager and was subsequently associated with corporate houses like Arvind Mills Limited, etc. Dr. Singh holds a PhD degree in Management and has also been associated with academia as Professor in Management with Specialization in Marketing.

Soumyen Sikdar

He has a B.Sc Economics Hons from Presidency College, Calcutta, M.Sc Economics Hons from University of Calcutta and PhD from University of Minnesota, USA.



Parthapratim Pal

Parthapratim Pal is Associate Professor at the Indian Institute of Management (IIM), Calcutta. He has a Ph.D. in Economics from Jawaharlal Nehru University, New Delhi. He has also been a *fellow* at the Cambridge Advanced Programme of Rethinking Development Economics. He works in the areas of macroeconomics, international trade and capital flows.



Srabani Roy Choudhury

Dr. Srabani Roy Choudhury, Associate Professor in Japanese Studies, Centre for East Asian Studies, School of International Studies, and Jawaharlal Nehru University has been associated with this university from 2006. Her primary area of interest is Japanese joint-venture operations in India and issue of people management. An alumni of from Jawaharlal Nehru University her Ph. D was on 'Human Resource Management of Japanese Multinationals: A Case Study of Transferability into Two Industries in Thailand and India', for which she was recipient of Japan Foundation scholarship. Her academic career began in 1998 with NIILM, a business school. In 2004, she moved to International Management Institute, New Delhi. During her tenure in these institutions she worked closely with many industrial forums as academic collaborator and evaluator. She is also engaged in international collaboration for providing micro level data on Indian consumers and other sections of the society.
